

Immanuel Church Dublin Child Safeguarding Statement (Feb 2026)



Immanuel Church Dublin operates under the auspices of Irish Church Missions, an Anglican mission organisation. It is also a member church of the Anglican Convocation of Europe.

Irish Church Missions provides religious, educational and recreational activities and services to children under 18 years of age through its local churches.

Irish Church Missions acknowledges its duty of care to safeguard and promote the welfare of children and is committed to ensuring safeguarding practice that reflects statutory responsibilities, government guidance and complies with best practice.

Irish Church Missions is committed to safeguarding children, having adopted a Safeguarding Policy which is in line with the Children First Act 2015 and associated guidelines from national bodies such as Garda Vetting and Tusla. Irish Church Missions recognises that the welfare and interests of children are paramount in all circumstances. The trustees, clergy, staff and volunteers are committed to ensuring that all children have a positive experience in a safe and child centred environment and are protected from abuse whilst participating in activities.

All churches operating under ICM's Safeguarding Policy have conducted a specific written risk assessment of any potential for harm to a child through their involvement in Church activities. The written risk assessment indicates the areas of potential harm, the likelihood of harm occurring, and lists the required policy, guidance, process and practice required to alleviate the risks. Site specific risks, which are in addition to those listed below, have been documented by the individual churches.

In addition to the local church risk assessments and the above policies and procedures named, the following procedures are in place throughout Irish Church Missions churches as part of its safeguarding policies and procedures:

- Procedures for the safe recruitment of volunteers or employees to work with children in our services.
- Procedures for provision of and access to child safeguarding training, including the identification and reporting of harm.
- Procedures for reporting child protection and welfare concerns to Tusla and An Garda Síochána.
- Procedures for maintaining a list of persons in each church who are mandated persons.
- Procedure for appointing a relevant person for this child safeguarding statement.
